

**ORDINANCE NO. 091719-02**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARTFORD, IOWA, 2019, BY AMENDING ORDINANCE CHAPTER 106.08.02 RECYCLING FEES.**

**BE IT ENACTED** by the City Council of the City of HARTFORD, Iowa:

**SECTION 1. NEW SECTION.** The Code of Ordinances of the City of HARTFORD, Iowa, 2019 is amended by amending Chapter 106, numbered 106.08.02, entitled RECYCLING FEES, which is hereby adopted to read as follows:

**106.08.02 Recycling Fee.** An additional fee of \$3.50 per month shall be charged to each customer receiving the Curb-It Recycling Program service.

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
