# **ORDINANCE NO. 101519-01**

# AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARTFORD, IOWA, 2019, BY AMENDING ORDINANCE CHAPTER 99.02 SEWER SERVICE CHARGES.

#### **BE IT ENACTED** by the City Council of the City of HARTFORD, Iowa:

**SECTION 1. NEW SECTION.** The Code of Ordinances of the City of HARTFORD, Iowa, 2019 is amended by amending Chapter 99, numbered 99.02, entitled SEWER SERVICE CHARGES, which is hereby adopted to read as follows:

**99.02 RATE.** Each customer shall pay sewer service charges for the use of and for the service supplied by the municipal sanitary sewer system based upon the amount of water consumed as follows:

#### Effective November 1, 2019

- 1. First 2,999 gallons or lesser amount per month, @ \$45.90
- 2. All over 2,999 gallons per month, @ \$12.56

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
