Council discussed scheduling a hard-financial audit; city clerk will arrange with the Iowa Department of Management. Motion by Goldsberry, seconded by Clark to hire Tom Bales to repair brakes on the city dump truck in the amount of \$1228.59 plus towing fees; motion carried unanimously by voice vote.
