Voluntary Pledge of Allegiance recited. Motion by Eckert, seconded by Smith to approve agenda items as written; motion carried by voice vote.

**MINUTES:** Motion by Goldsberry, seconded by Sophia approving Regular Council Meeting minutes from April 21, 2020; motion carried by voice vote.

**RECEIVE AND FILE:** Motion by Smith, seconded by Barton to receive and file the Sherriff's April 2020 Report; motion carried by voice vote.

**CONSENT AGENDA:** Motion by Goldsberry, seconded by Barton to approve monthly expenditures & additional expenditures; motion carried unanimously by roll call vote. Motion by Smith, second by Barton to approve payroll for Travis Goldsberry, Steve Eckert, Brandon Bennett and Cynthia Crippen; motion carried by roll call votes; AYES: Jors, Smith, and Barton; ABSTAIN: Goldsberry and Eckert.

**OLD/UNFINISHED BUSINESS:** Goldsberry and PWS to talk with Attorney Brick addressing final Snyder bill to move forward. Discussed new Website additional changes TBD. Motion by Eckert; second by Goldsberry to waive 2<sup>nd</sup> and 3<sup>rd</sup> readings of Ordinance 042120-1, motion carried unanimously by roll call vote. Motion by Eckert second by Barton approving Fire Recovery EMS contract, motion carried unanimously by roll call vote.
