Officials present via Zoom: Mayor Kandi S. Petry, council members: Andrea Jors, Dana Smith, Crystal Barton, Mark Goldsberry and Sophia Eckert; Others attending: City Clerk Crippen, Public Works Senior Steve Eckert, Fire Chief Zack Prickett and Attorney Matt Brick. Mayor Petry called the meeting to order at 6:38 P.M. Voluntary Pledge of Allegiance recited. Motion by Eckert, seconded by Smith amending the agenda to add Public Comments; motion carried by voice vote.

Mayor welcomed guests for public comment; Luke Boers addressed his concerns on the Swimming Pool Ordinance and Notification of Council Meeting Agenda's. NEW COUNCIL BUSINESS: Nuisance Abatement tabled for July's Regular Council Meeting. Gworks Training tabled for July's Regular Council Meeting. Posting Monthly Agenda to website discussed and approved; add to regular posting resolution in December. Motion by Eckert; second by Barton approving Public Works 2020 Budget Purchase's for \$9825 & tabling UTV purchase pending additional research, motion carried unanimously by roll call vote. Motion by Eckert; second by Goldsberry approving LL Pelling Bid for street repairs with corrections to streets named in the bid, replacing Main South with Main North and Main North with Paint North; motion carried unanimously by roll call vote.

GENERAL COUNCIL DISCUSSION: Updates given on status of Mural projects and repairs to Basketball court water retention issue. Discussion around nuisance letters for review and mailing.

ADJOURNMENT: Motion by Eckert, seconded by Jors to adjourn; motion carried by voice vote. Mayor Petry adjourned regular city council meeting at 8:16 P.M.
