Voluntary Pledge of Allegiance recited. Motion by Eckert, seconded by Jors approving agenda with old business items, e. Park Design/setup and f. Food Trucks, removed to future meeting; motion carried by voice vote.

OLD/UNFINISHED BUSINESS: Motion by Wilson; seconded by Barton approving Ordinance 102020-05 Amending the Code of Ordinance Chapter 75 All-Terrain Vehicles and Snowmobiles of the City of Hartford, IA to add Utility Terrain Vehicles and Golf Carts to the ordinance; motion carried unanimously by roll call vote. Motion by Eckert; seconded by Jors approving Resolution 010521-2 Authorizing Salaries and Hourly Wages with a 2.5% COLA increase for City Employees for the Fiscal Year July 1st, 2021 and Ending June 30th, 2022; motion carried unanimously by roll call vote. Discussed Old Public Works Building/Fire Station Storage Insulation Public Works to get bids to insulate the building. Medical Waste Removal Contract will be reviewed. Motion by Eckert; seconded by Goldsberry accepting LL Pelling Co. pricing for the year 2021; motion carried unanimously by roll call vote.
