AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARTFORD, IOWA, 2020, BY AMENDING ORDINANCE 35.14 EMERGENCY RESCUE SERVICE.

BE IT ENACTED by the City Council of the City of HARTFORD, Iowa:

SECTION 1. SECTION MODIFIED. Chapter 35, Section 14(1) Fees of the Code of Ordinances of the City of Hartford, Iowa is repealed, and the following adopted in lieu thereof:

35.14 EMERGENCY RESCUE SERVICE. The department is authorized to provide Emergency rescue services and the accidental injury and liability insurance provided for herein shall include such operation.

1. Fees. The following schedule of charges shall be imposed for all EMS calls made by the Hartford Fire Department:

Paramedic Tier	\$250.00
Creating Landing Zone	\$500.00
Mileage and Cost	\$21.00 per loaded mile
Death Determination	\$100.00
Private Pay	\$100.00
Private Ambulance Standby	\$150.00 per hour

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this

ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
