

**ORDINANCE NO. 101822-2**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES  
CHAPTER 69.11 NO PARKING ZONES OF THE CITY OF  
HARTFORD, IOWA, BY ADDING A NEW SECTIONS FOR NO  
PARKING**

**BE IT ENACTED** by the City Council of the City of HARTFORD, Iowa:

**SECTION 1. NEW SECTION.** The Code of Ordinances of the City of HARTFORD, Iowa, 2019 is amended by adding a new Section in Chapter 69.11, which is hereby adopted to read as follows:

**69.11.11 East Street, on the west side from Walnut Dr. going south to the end of the street.**

**69.11.12 East Street, on the east side from Walnut Dr. Stop Sign south 50'**

**69.11.13 North View Court, on the north side from East Street going west to the end of the street.**


**69.11.14 North View Court, on the south side from East Street going west 50'**

**SECTION 2. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


**SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
