BE IT ENACTED by the City Council of the City of HARTFORD, Iowa:

SECTION 1. <u>Purpose</u>. The Purpose of this amendment is to raise the solid waste fee to meet the current charges to the City of Hartford for solid waste collection.

SECTION 2. <u>Section Amended.</u> Section 106.08.01 entitled COLLECTION FEES, which is hereby adopted to read as follows:

Effective July 1, 2025

106.08.1 Fee for Collection. The fee for solid waste collection and disposal service, used or available, is as established by the Council. The Council reserves the right to adjust, modify or eliminate the fee in special circumstances. Monthly collection fee, Environmental fee, Fuel fee and administration fee effective July 1, 2025, is as follows:

Regular

\$ 18.93 per month

Senior Citizen

\$ 11.85 per month

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
