ORDINANCE NO. 052025-1

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARTFORD, IOWA, BY AMENDING ORDINANCE CHAPTER 122.06 APPLICATION FOR LICENSE AND 122.07.01 LICENSE FEES PEDDLERS, SOLICITORS AND TRANSIENT MERCHANTS LICENSE FEES.

BE IT ENACTED by the City Council of the City of HARTFORD, Iowa:

SECTION 1. <u>Purpose</u>. The Purpose of this amendment is to combine the application fee and adjust the per-person fee to cover the cost of investigating the facts stated therein:

122.06 APPLICATION FOR LICENSE. An application in writing shall be filed with the Clerk for a license under this chapter. Such application shall set forth the applicant's name, permanent and local address, and business address if any. The application shall also set forth the applicant's employer, if any, and the employer's address, the nature of the applicant's business and the length of time sought to be covered by the license.

122.07.01 LICENSE FEES. Solicitors. For each person actually soliciting (principal or agent), a fee for the principal of Twenty dollars (\$20.00) per application to cover the cost the cost of investigating the facts stated therein.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
