ORDINANCE 071525-1

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HARTFORD, IOWA BY AMENDING PROVISIONS PERTAINING TO FIREWORKS

BE IN ENACTED by the City Council of the City of Hartford, Iowa:

SECTION 1. Section 45.22.2 of the Code of Ordinances of the City of Hartford, lowa is repealed and the following adopted in lieu thereof:

45.22.2 Limitations

- A. It is unlawful for any person to use or explode consumer fireworks on days and times other than the following dates and times:

 July 3rd 9am-10pm

 July 4th 9am-11pm

 December 31st 9am to 12:30am (Jan 1st)

 of each year, all dated inclusive.
- B. A person shall not use consumer fireworks on real property other than that person's real property or on the real property of a person who is consented to the use of consumer fireworks on that property.
- C. A person who violates this section commits a simple misdemeanor. A Court shall not order imprisonment for violation of this section.

SECTION 2. <u>SEVERABILITY CLAUSE.</u> If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudicated invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This Ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
